11 You may demand that the petitioner file this lawsuit with the court. If you do so, the  
12 demand must be in writing and must be served upon the person signing this summons. Within  
13 14 days after you serve the demand, the petitioner must file this lawsuit with the court, or the  
14 service on you of this summons and complaint will be void.

17 If you wish to seek the advice of an attorney in this matter, you should do so promptly so  
18 that your written response, if any, may be served on time.

20 This summons is issued pursuant to rule 4 of the Superior Court Civil Rules of the State of
